# *INSECT ENCOUNTERS* AT THE 2006 FLORIDA STATE FAIR

In 1995, a Florida State Fair director asked the Florida Entomological Society (FES) to set up an entomological exhibit in the Ag Hall of Fame Pavilion. Since then, *Insect Encounters* has blossomed into an unexpectedly popular forum for science education outreach. Thousands of visitors pass by the exhibit's booths each February to see live insects and informational displays, ask questions, and pick up brochures and handouts.

Insect Encounters has been a cooperative effort among multiple research, educational, and regulatory organizations in Florida, including the FES, Division of Plant Industry (DPI), Florida Mosquito Control Association (FMCA), University of Florida (UF) Department of Entomology and Nematology, United States Department of Agriculture (USDA), and Walt Disney World. Over the years, students in school bus tours and other visitors to the Fair have encountered a series of displays, videos, and live exhibits including, at different times, bees, cockroach races, fire ant and termite colonies, flies, mosquito larvae, and stored product insects. Counts provided by Florida State Fair staff indicate that the number of visitors has grown from about 6,000 in 1996 to about 87,000 in 2006.

## STUDENT ACTIVITIES COMMITTEE ANNOUNCEMENTS

A competition for the best M.S and Ph.D. student paper will be held at the upcoming 89<sup>th</sup> Annual Meeting of the Florida Entomological Society, **July 23 to 26, 2006**, at the Jupiter Beach Resort & Spa, in Jupiter Beach. Awards of \$175, \$150, and \$125 will be made to the first, second and third place papers, of each category, respectively. Students wishing to present a paper in the student paper competition must be current members of the Florida Entomological Society.

Students should submit paper title and abstract using the standard submission form (see page 7) and should indicate that the submission is for the student competition. Papers should be **10 minutes long** with 2 minutes allowed for questions. The judging criteria are as follows:

*Organization* (20 points) - sequence of topics logical and effective; introduction, body of talk (material and methods, results), and conclusions coherent; time well used.

*Delivery* (20 points) - poise, audibility, expression, eye contact, use of pointer.

*Visual aids* (15 points) - appropriate for subject matter, legible, eye-appealing.

*Subject matter* (35 points) – relevance of research, important questions addressed, appropriate methods to accomplish objectives, conclusions based solely on results and avoid a repetition of results.

*Handling of questions* (10 points) - questions made clear to audience; answers logical and appropriate.

*Conforming to time constraints* (maximum of 8 penalty points; 1 point for each 15 seconds overtime or 30 seconds undertime).

# SCHOLARSHIPS, MINIGRANTS AND TRAVEL GRANTS

Each year the Florida Entomological Society presents three scholarships and ten minigrants to student members at the Annual Meeting. Travel grants are also awarded at the meeting.

To apply for these awards, the **applicant must be a current FES student member**. The format for applying for each of the Florida Entomological Society-sponsored awards follows:

*Scholarships* - The Florida Entomological Society will award three \$500 scholarships to students majoring in entomology or a related discipline. The application requirements are:

Along with being a current member of the Florida Entomological Society, students must be enrolled fulltime with at least one year remaining in his or her degree program. Applications from undergraduate students will be considered.

The application should include:

- 1. Transcripts
- 2. Letters of recommendation from two faculty members
- 3. A curriculum vitae
- 4. A letter from the applicant, stating his or her future plans in the field of entomology

Send all materials in one package only (instructions at the end of this article).

*Minigrants* - The Florida Entomological Society will award ten minigrants of \$100 each to student members for entomological research.

Applications should include:

- 1. A one-page description of the student's research
- 2. A list of the items with the final cost to be purchased.

Dr. Julio Medal is organizing the 'Third Latin-American Short-Course on Biological Control of Weeds'. It will be held on June 12-15, 2006 at the Seminole Plaza Hotel in Managua, Nicaragua. Participants will gain a basic understanding of the principles and concepts of biological control of weeds using insects and pathogens, and receive training on how to implement a weed biocontrol program. Group discussions will focus on the prospects for and limitations of biological weed control in Latin America. About 15 weed biocontrol experts and 100 trainees from at least 15 developing countries will be involved. After completing this course, participants will be able to implement weed biocontrol programs in their own countries, as well as work with international agencies in the region.
